PUBLIC NOTICE INVITATION TO BID

Sealed Bids are hereby solicited under section 103 of the general municipal law by the Saranac Lake Village Board of Trustees for the installation of concrete curb and concrete sidewalk. All concrete will be supplied by the village on streets within the village. Estimated Quantities are 1,200 L.F. standard 6" wide by 18" tall curb, 1,200 L. F. mountable curb and 8,800 S.F. 4" and 6" sidewalk. Bid to be based by the square feet and linear feet as well as a separate mobilization/demobilization of equipment to jobsite. The Village reserves the right to increase or decrease quantities as deemed necessary. Sealed bids will be opened April 1, 2020 at 2:30 PM at the Village Office 39 Main Street Saranac Lake NY 12983. Sealed bids should be addressed to the Village Clerk at 39 Main Street Suite 9 Saranac Lake NY 12983.

INVITATION TO BID

SEALED BIDS ARE HEREBY SOLICITED UNDER SECTION 103 OF THE GENERAL MUNICIPAL LAW BY THE VILLAGE BOARD OF THE VILLAGE OF SARANAC LAKE, FOR CONCRETE CURB AND CONCRETE SIDEWALK. WORK UNDER THIS CONTRACT WILL BE AS A SUBCONTRACTOR TO THE VILLAGE OF SARANAC LAKE. ALL PROJECT DETAILS, SPECIFICATIONS, AND INFORMATION ARE CONTAINED IN THESE ATTACHED DOCUMENTS.

- 1 - Bids are to be addressed to the Village Clerk and the SEALED ENVELOPE SHOULD BE PLAINLY MARKED WITH THE NAME OF THE ITEM TO BE BID AND THE DATE OF THE BID OPENING.
- 2 - Bids must be detailed categorically in the same order as specification to facilitate reading and study.
- 3 - The bidder must be a duly authorized representative of the company he represents for a period of at least one year.
- 4 - If the bidder proposes to modify a product or service as to make it conform to the requirements of the Invitation for Bids, he shall (a) include in his bid a clear description of such proposed modifications, and (b) clearly mark any descriptive material to show the proposed modifications.
- 5 - Modifications proposed after bid opening to make a product or service conform to the specifications will not be considered.
- 6 - A non-collusion statement must accompany the bid(s).
- 7 - The Village reserves the right to reject, in its sole discretion, any apparent low bid on the ground that the bidder is not a responsible bidder, based on objective criteria, including but not limited to proper capabilities, experience, equipment, qualifications and other factors.
- 8 - The Village reserves the right to reject any and all bids if, in its' opinion, such action is in the best interest of The Village.
- 9 - All items in the following specifications shall be deemed to include the words "or approved equal". The bidder must submit with bid, detailed specifications, circulars, and all necessary data on supplies, and services he proposes to furnish. If supplies or services offered differ from the provisions contained in this specification, such differences must be explained in detail, and bid will receive careful consideration that such deviations do not depart from the intent of these specifications and are to the best interests of the Village Board.

All federal and state taxes will be excluded. Tax exemption certificates will be furnished to the successful bidder.

Description of Items are as follows:

Item #1 and Item #2 is to include the price for the following:

VILLAGE OF SARANAC LAKE WILL BE PURCHASING ALL CONCRETE NEEDED TO COMPLETE THIS OPERATION. CONTRACTOR WILL BE IN CHARGE OF THE SCHEDULING.

- 6” wide curb by 18” tall Type J concrete
- Mountable Curb (per attached detail sheet) Type J concrete
- all necessary curing and protection of new concrete curb during initial setting that will include any cold weather provisions for protection.
- all mobilization and demobilization to the site
- Village DPW to take care of all excavation for curb as well as any necessary backfilling prior to sidewalk construction.
- quantities are approximate and will be paid by the actual installed and measured linear foot.**

Item #3 is to include the price for the following:

VILLAGE OF SARANAC LAKE WILL BE PURCHASING ALL CONCRETE NEEDED TO COMPLETE THIS OPERATION. CONTRACTOR WILL BE IN CHARGE OF THE SCHEDULING.

- 4” thick and 6” thick concrete sidewalk of various widths using Type F concrete
- Village DPW to take care of all backfilling behind the curb as well as fine grading for sidewalks
- all necessary curing and protection of new concrete sidewalk during initial setting that will include any cold weather provisions for protection.
- all mobilization and demobilization to the site
- quantities are approximate and will be paid by the actual installed and measured square foot.**
