Frequently Asked Questions about COVID-19 Vaccine

Who is eligible for COVID-19 vaccine?

Ages 5 and older.

Pfizer vaccine is available for those 5 and up.

Moderna and Johnson and Johnson vaccines are available for those 18 and up.

Who is eligible for a COVID-19 booster?

Boosters are approved for those 16 and older.

COVID-19 Vaccine booster shots are available for Moderna (ages 18 and up) and Pfizer (ages 16 and up) vaccine recipients who completed their first 2 doses at least 6 months ago as well as Johnson and Johnson vaccine recipients (18 and up) who had their shot at least 2 months ago.

What about mixing and matching boosters?

You may choose which COVID-19 vaccine you receive as a booster shot. Some people may have a preference for the vaccine type that they originally received, and others may prefer to get a different booster. CDC's recommendations now allow for this type of mix and match dosing for booster shots.

Where is vaccine available?

First, second, and booster doses of COVID-19 vaccine are widely available. If you have access to the internet, the easiest way to search for an appointment is to go to [Vaccines.gov](https://www.vaccines.gov) - [Find COVID-19 vaccine locations near you](#) to find vaccine locations close to your zip code. If you do not have internet access or wish to search for vaccine at separate locations, they are listed below.
